Southern Nuclear has reviewed Revision 29 to the FNP Security Plan concerning VA checks, and has determined that the revision does not decrease the safeguards effectiveness of the FNP Security Plan. Additionally, the VA check process removed from the FNP Security Plan has been incorporated in an FNP Security Procedure, and the process was better defined and improved.

Also note that the FNP Security Plan revision concerning a biometrics access control system (Revision 28) will not be issued until the NRC Staff approves the revisions, and the biometrics access control system has been implemented.
