SUBJECT: ELIGIBILITY REQUIREMENTS FOR CANDIDATES TO BE LICENSED AT PLANTS SUMMER AND FARLEY

On September 27, 1984, representatives of the Georgia Power Company met with the NRC in Bethesda, Maryland to discuss the eligibility requirements that must be satisfied by Georgia Power Company employees applying for licenses at V. C. Summer and J. M. Farley Nuclear Plants. The attendance list is attached as Attachment A to this summary. The Georgia Power Company Off-Site Licensing Program Summary is attached as Attachment B to this summary. The meeting was held at the request of the NRC.

Georgia Power Company representatives described the program that they have established to provide operational experience for future Vogtle operators. Under this program, eight prospective Vogtle operators would be licensed by the NRC as senior reactor operators and serve in that capacity at plants Summer and Farley. Georgia Power Company representatives described the qualifications of these eight candidates and representatives of South Carolina Electric and Gas Company and Alabama Power Company described the training they would receive at Summer and Farley. NRC representatives noted that the candidates did not have sufficient operating experience to meet the NRC license eligibility criteria normally applied to candidates for SRO licenses at operating reactors. Georgia Power Company representatives agreed to support the applications for these candidates by submitting written justification to NRC Region II for waiver of these eligibility criteria. They also agreed to submit certifications by South Carolina Electric and Gas Company and Alabama Power Company that these individuals would not serve as shift supervisors. NRC representatives reaffirmed their support for this Georgia Power Company program.
