Gentlemen:

This refers to the inspection conducted by Mr. Brandkamp of this office on October 23, 1973 at the Oyster Creek Reactor Site, Forked River, New Jersey of activities authorized by AEC License No. DPR-16 and to the discussions of our findings held by Mr. Brandkamp with Mr. Carroll and other members of your staff at the conclusion of the inspection.

The areas examined during the inspection were limited to the waste barrel removal operation which was in progress at the time of the inspection. Within these areas, the inspection consisted of selected examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

During this inspection, it was found that certain of your activities appeared to be in violation of AEC requirements, and other activities appeared to raise questions concerning the safety of operations. The items and references to the pertinent requirements and to generally accepted guidance are listed in the enclosure to this letter. This letter constitutes a notice sent to you pursuant to the provisions of Section 2.201 of the AEC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office within 20 days of your receipt of this notice, a written statement of explanation in reply, including: (1) steps which have been or will be taken by you to correct the violations, and the results achieved; (2) steps which will be taken to avoid further violations; and (3) the date when full compliance will be achieved. With respect to the question concerning the safety of operations, please include in your response your comments concerning these items, a description of any steps that have been or will be taken to correct them, a description of any steps that have been or will be taken to prevent recurrence, and the date all corrective actions or preventive measures were or will be completed.
