Gentlemen:

This refers to the inspection conducted by Mr. Meyer of this office on April 18-20, 1973 at Oyster Creek Station of activities authorized by AEC License No. DPR-16 and to the discussions of our findings held by Mr. Meyer with Messrs. Carrol, Sullivan and Reeves of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Regulatory Operations Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with plant personnel, measurements made by the inspector, and observations by the inspector.

Our inspector examined the status of your corrective actions as described in your letter to this office, dated March 28, 1973. It was noted that installation of a locking mechanism on the door to the solid radwaste storage room and installation of drain extensions in the liquid radwaste catch basin had not been completed. We will review these matters during a subsequent inspection. We have no further questions concerning the other matters. Our inspector also examined those activities conducted under your license relating to the subject covered in your letter to the Directorate of Regulatory Operations, dated April 3, 1973. We have no further questions regarding this matter.

Within the scope of this inspection, no violations or safety items were observed.

In accordance with Section 2.790 of the AEC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the AEC's Public Document Room. If this report contains any information that you (or your contractor) believe to be proprietary, it is necessary that you make a written application within 20 days to this office to withhold such information from public disclosure.
