#### Camtlemen:

This letter refers to the meeting held with you and members of your staff and with senior corporate representatives of the General Public Utilities Corporation (GPU) at our Region I Regulatory Operations office on November 5, 1973 relative to activities authorized by AEC License No. DPR-16.

Areas discussed in this meeting are described in the Regulatory Operations Inspection Report and its proprietary enclosure which is enclosed with this letter. Since the proprietary enclosure discusses security measures used for the physical protection of your facility, it is being withheld from public disclosure pursuant to 10 CFR 2.790(d). Within these areas, discussions cantered on apparent systematic and managerial control deficiencies which have persisted since our previous meeting held on April 24, 1973 at your offices in Morristown, New Jersey. The results of this prior meeting were reported to you in our letter dated June 7, 1973.

We understand, based upon the November 5, 1973 meeting, that substantive changes in the facility organization have taken place, implementing procedures for the Quality Assurance Program are being prepared, and that the GPU organization is providing additional support at the facility in deficient areas. Your actions regarding these matters will be reviewed during our augmented inspection program of your licensed activities.

### 3. Environmental Group
