UPCOMING MIDLAND MEETING SUBJECT:

' As you know, we have scheduled a meeting for Tuesday, March 30 at 9:00 a.m. with Consumers Power Company to discuss the Midland underpinning activity. The principal points which Jim Cook has indicated that he wishes to discuss are (1) the practicality of requirements, (2) the transition between the various phases of the project, and (3) to gain an understanding that Q listed items may include more activities than what are normally identified as being identified safety related activities and are related enforcement activities in this area.

Also in my discussions with Jim Cook, he agreed to identify for us significant issues in the underpinning activity which appear important for us to intimately involved in in terms of conducting our inspections. Secondly, I discussed with him the need for having a single point of communication at the Midland site for Ross to deal with on a day-to-day basis.
