Dear Sir,

Louisiana Power & Light has completed an aging and radiation analysis for all mechanical equipment located in a harsh environment as requested by references one (1) and two (2). The analysis demonstrated the acceptable qualification of all mechanical equipment for the intended service life and environmental conditions.

The analysis was performed in accordance with the Arrhenius accelerated aging technology as specified in the NRC Safety Evaluation Report, Supplements 5 and 8, and amplified in NUREG-0588.

The analysis covered all safety-related valves, pumps, and fans previously submitted under Document Number LW3-1253-83 dated September 14, 1983. Individual analysis reports are available and contain the following information:

- * Manufacturer
- * Equipment Type & Size
- * Location
- * TAG and UNID Number
- * Environmental Service Conditions
- * Accident Service Conditions
- * Materials of Construction
- * Service Life

The results of the analysis are being used to update the current LP&L maintenance and surveillance program.


