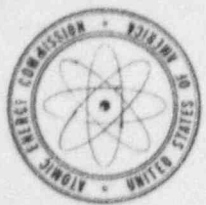

OYSTER CREEK ENVIRONMENTAL TECHNICAL SPECIFICATIONS

Environmental issues concerning the Oyster Creek facility have been the subject of prior requests for action. (Reference - memorandum Brunner to Thornburg dated February 6, 1974 and O'Reilly to Davis dated June 6, 1974.)

Subsequent to these requests, additional public attention has been focused concerning the shipworm problem, PUC reports and the purported plight of marina operators in this area.

Barring changes in the current schedule concerning required shutdowns for seismic shock suppressor inspections, an outage will commence in mid March 1975 and, predictably, fish kills will occur.

Although Region I will continue to respond to winter incidents, we continue to believe that issuance of Environmental Technical Specifications in 1974 is warranted, necessary and in the best interests of the Commission.
