This refers to a special inspection conducted by Mr. T. Kenny of this office on December 10-19 and 22, 1984 at Indian Point Nuclear Generating Station, Unit 2, Buchanan, New York of activities authorized by NRC License No. DPR-26, and to the discussions of our findings held by Mr. T. Kenny with Mr. M. Selman and members of his staff at the conclusion of the inspection.

As a result of a 50.72 report made by your staff regarding "Throttled Auxiliary Feed Water Regulating Valves," our resident inspector conducted a special inspection into the reasons for these valves being throttled in the non-conservative direction.

As a result of the inspection documented within the enclosed report, certain concerns contributing to the throttle valves being set non-conservatively have been identified. Although no apparent violation has been identified in this event, you are requested to investigate the areas of concern and provide written response to Region I within 30 days, including in that response the corrective actions you intend to implement in order to eliminate the concerns.
