Gentlemen:

This refers to the inspection conducted by Mr. Mann of this office on December 27 and 28, 1973, at the Oyster Creek Nuclear Generating Station of activities authorized by AEC License No. DPR-16 and to the discussions of our findings held by Mr. Mann with Mr. Reeves and Mr. Scalsky of your staff at the conclusion of the inspection, and to a subsequent telephone discussion between Mr. Mann and Mr. Ross on January 3, 1974.

Areas examined during this inspection are described in the Regulatory Operations Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Our inspector also verified the steps you had taken to correct the violations brought to your attention in a letter dated October 30, 1973 following our last inspection. We have no further questions regarding these matters.

During this inspection, it was found that one of your activities appeared to be in violation of an AEC requirement. The item and reference to the pertinent requirement are listed in the enclosure to this letter. This letter constitutes a notice sent to you pursuant to the provisions of Section 2.201 of the AEC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office within 20 days of your receipt of this notice, a written statement of explanation in reply, including: (1) corrective steps which have been or will be taken by you, and the results achieved: (2) corrective steps which will be taken to avoid further violations: and (3) the date when full compliance will be achieved.

If we do not hear from you in this regard within the specified period, the report will be placed in the Public Document Room.
