This refers to the routine inspection report conducted by Mr. Nemen M. Terc of this office and other members of the NRC Team on October 1-5, 1984, at the Three Mile Island Nuclear Station, Unit 1 of activities authorized by NRC License DPR-50 and to the discussions held by Mr. Terc with Mr. H. D. Hukill and others of your staff at the conclusion of the inspection.

The area examined during this inspection was limited to observation of your emergency exercise conducted on October 3, 1984. Within this area, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors. Within the scope and limitations of the exercise scenario, the emergency response actions of your staff demonstrated the capability to adequately and efficiently implement your emergency plans and procedures to provide protective measures for the health and safety of the public.

Within the scope of this inspection, no violations were observed. In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office by telephone within ten days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.

No reply to this letter is required, however, we understand that actions will be taken to correct or improve certain areas as identified in the report. Your cooperation with us in this matter is appreciated.
