This letter refers to the routine Safeguards Inspection of your activity at Diablo Canyon Power Plant, Unit 1 authorized under NRC License No. DPR-76 conducted by Mr. D. Schaefer of this office on January 21-25 and 29, 1985. It also refers to the discussion of the inspection findings held by the inspector with Mr. R. C. Thornberry, Plant Manager and members of his staff on January 25, 1985.

Areas examined during this inspection included activities related to physical protection as described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and records, interviews with facility personnel and observations by the inspectors.

Within the scope of this inspection, no violations were observed.

In accordance with Section 2.790(d) of the NRC's "Rules of Practice", Part 2, Title 10 Code of Federal Regulations, documentation of the findings of your safeguards and security procedures are exempt from public disclosure; therefore, the enclosed report will not be placed in the Public Document Room and will receive limited distribution.
