SUBJECT: SUMMARY OF MEETING TO DISCUSS RBS TECHNICAL SPECIFICATION

The meeting was held in Bethesda Maryland on January 10, 1985. A list of persons participating in the meeting is included as Enclosure 1. The generic pathway and milestones for development of technical specifications was handed out and is included as Enclosure 2.

The first draft of the RBS technical specifications was completed in early January and will be modified as a result of meetings with GSU to reflect plant specific differences between the standard technical specifications and RBS design. GSU was informed that the FSAR will need to be updated to reflect plant design, programs and organizations prior to final technical specification approval. A meeting on site the week of January 28, 1985 was established. This meeting will be used as a vehicle to discuss further the first draft and the plant specific differences.
