Taylor of this office and two NRC consultants during the period May 14-August 31, 1984, of activities authorized by NRC Construction Permit CPPR-147 for Wolf Creek, Unit 1, and to the discussion of our findings with Mr. W. J. Rudolph, and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included: followup to allegations, installation of electrical equipment, licensee action on 10 CFR 50.55(e) items, licensee actions on IE Bulletins, and licensee actions regarding allegations. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.

Two new unresolved items are identified in paragraphs 2.k. and 3.a. of the enclosed inspection report.
