Subject: Inspection No. 50-293/85-02 (Special Inspection and Enforcement Conference)

This refers to the special safety inspection conducted by Region I staff members on January 15-18, 1985, at the Pilgrim Station. The findings of this inspection were discussed with Mr. A. L. Oxsen. This also refers to an Enforcement Conference held in NRC Region I on January 31, 1985.

The inspection was conducted to review, among other matters, the adequacy and implementation of corrective actions for resumption of sludge lancing and your evaluation of high reading TLDs identified on December 14 and 22, 1984. The Enforcement Conference was held to discuss the unauthorized entry of an individual into the 'C' Monitor Tank (See Inspection Report 50-293/84-44). These and other related topics are discussed in the enclosed inspection report.

No reply to this letter is required. You will be notified of our evaluation of appropriate enforcement action at a later date.
