Re: Report of a minor change to the Physical Security Plan of the Oregon State University TRIGA Reactor (OSTR) under the provisions of 10 CFR 50.54(p); License No. R-106, Docket No. 50-243

Gentlemen:

In accordance with the requirements of 10 CFR 50.54(p), Oregon State University hereby reports a change to the OSTR Physical Security Plan which was made without prior NRC approval. The change was reviewed by the OSTR physical security staff and the Reactor Operations Committee, and it was concluded that the safeguards effectiveness of the Physical Security Plan would not be reduced by making the indicated change.

As requested in NRC Generic Letter No. 84-18, the safeguards information being reported, and the transmittal letter, have been prepared as per Generic Letter No. 82-39. In keeping with this, we have described the change to the OSTR Physical Security Plan in an enclosure (Attachment No. 1) to this letter.

If there are questions regarding the described change, please let us know. We are planning to incorporate this letter with Attachment No. 1 into the list of documents which currently comprise our Physical Security Plan. Additionally, in accordance with Section 2.790 of 10 CFR 2, or other applicable parts of the NRC's regulations dealing with disclosure of physical security information, we request that the safeguards information in Attachment No. 1 to this letter be withheld from public disclosure. Thank you for your consideration of this change.
