This refers to the routine inspection conducted by Messrs. Peter S. Koltay and Lawrence W. Rossbach of this office on September 16, 1984 to October 15, 1984 at Indian Point 3 Nuclear Power Plant, Buchanan, New York, of activities authorized by NRC License No. DPR-64, and to the discussions of our findings held by our inspectors with yourself and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the report enclosed with this letter. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the revised NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register (47 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

Your cooperation with us in this matter is appreciated.
