Gentlemen:

We have identified a problem area in the Technical Specifications for the Oyster Creek Nuclear Generating Station, Unit I facility which involves the statement of the maximum allowable reactor vessel heatup and cooldown rates. By specifying a temperature change rate in "oF/hr", the time interval over which the change is to be averaged is not obvious.

In order to increase operational flexibility and to decrease the possibility of a Technical Specification violation, heatup and cooldown rates, wherever specified, should be expressed in "___OF increase (or decrease) in any one hour." Accordingly, please submit proposed changes to the appropriate sections of the Technical Specifications for Oyster Creek Nuclear Generating Station, Unit 1 as part of a future application for license amendment.
