By letter dated January 5, 1996, Entergy Operations, Inc. (EOI), licensee for Arkansas Nuclear One, Units 1 and 2, Grand Gulf Nuclear Station, River Bend Station, and Waterford Steam Electric Station, Unit 3, requested alternatives to Title 10 of the Code of Federal Regulations, Section 50.55a, "Codes and Standards," under the provisions of paragraphs (a)(3)(i) and (a)(3)(ii). Our review with respect to authorizing alternatives as part of the licensee's ISI programs for the five nuclear units is continuing and we expect to issue our findings in the near future.

As related to the alternative for IST programs, we have determined that the request did not contain sufficient information in order to make a determination, pursuant to the provisions of 10 CFR 50.55a(a)(3), of the acceptability of continuing the current programs. Guidance on submitting plant-specific information for further review is given in the enclosed safety evaluation (SE).
