## Gentlemen:

This refers to the inspection conducted by Mr. Bores of this office on March 18-20, 1975 at the Oyster Creek Nuclear Generating Station site of activities authorized by AEC License No. DPR-16 and to the discussions of our findings held by Mr. Bores with Mr. Ross, Mr. Reeves and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

During this inspection, it was found that certain of your activities appeared to be in violation of AEC requirements. The items and references to the pertinent requirements are listed in the enclosure to this letter. This letter constitutes a notice sent to you pursuant to the provisions of Section 2.201 of the AEC's "Rules of Practice", Part 2. Title 10. Code of Federal Regulations. Section 2.201 requires you to submit to this office within 20 days of your receipt of this notice, a written statement of explanation in reply, including: (1) corrective steps which have been or will be taken by you, and the results achieved; (2) corrective steps which will be taken to avoid further violations: and (3) the date when full compliance will be achieved.

In accordance with Section 2.790 of the AEC's "Rules of Practice", Part 2. Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room. If this report contains any information that you (or your contractor) believe to be proprietary. It is necessary that you make a written application within 20 days to this office to withhold such
