Gentlemen:

This refers to the routine safety inspection conducted by Messrs. J. A. Grobe, D. E. Keating and G. F. O'Dwyer of this office on November 20, 1984, through January 7, 1985, of activities at Perry Nuclear Power Plant, Units 1 and 2, authorized by NRC Construction Permits No. CPPR-148 and No. CPPR-149, and to the discussion of our findings with Messrs M. D. Lyster, F. R. Stead, J. J. Waldron and C. M. Shuster at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

No items of noncompliance with NRC requirements were identified during the course of this inspection.

However, we remain concerned with your handling of Open Item No. 440/84-11-09, control of temporary alterations, as discussed in Paragraph I.6.c of the enclosed report. While this item was previously resolved based on your revision to a Nuclear Test Section procedure in July 1984, our review during this inspection indicates that the procedural administrative controls were not implemented and were later deleted in a revision to that procedure, in December 1984. You are requested to respond in writing to this matter within thirty days of the date of this letter addressing steps you have taken or will take to ensure that procedure revisions are properly implemented and that corrective action to identified deficiencies is lasting and permanent.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosure will be placed in the NRC's Public Document Room.
