The referenced letter and Callaway Facility Operating License NPF-30, License Condition C(5)(a) concern the operability of the Halon system in the north electrical penetration room (fire area A-18). This license condition required the Halon system be operable within 60 days of acquisition of the 100% power data for thermal and dynamic testing.

The purpose of this letter is to inform you the Halon concentration test for the north electrical penetration room was completed on February 5, 1985 and the results were approved by the Onsite Review Committee on February 8, 1985. Callaway startup testing was completed on December 19, 1984.
