Gentlemen:

This refers to the inspection conducted by Mr. Greenman of this office on February 4-5, 1975 at Oyster Creek, Forked River, New Jersey of activities authorized by AEC License No. DPR-16 and to the discussions of our findings held by Mr. Greenman with Mr. Carroll of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no items of noncompliance were observed.

In accordance with Section 2.790 of the AEC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room.
