This refers to the inspection conducted by Mr. Walton of this office on February 6 and 8, 1975 at Oyster Creek Nuclear Station of activities authorized by AEC License No. DPR-16 and to the discussions of our findings held by Mr. Walton with Mr. Carroll of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter.
