Tapia of this office during the period May 29 through June 8, 1984, of activities authorized by NRC Construction Permit CPPR-103 for the Waterford Steam Electric Station, Unit 3, and to the discussion of our findings with members of your staff at the conclusion of the inspection.

Areas examined during the inspection included test results evaluation; review of IE Bulletin No. 79-14; and a review of the Independent Design Review conducted by Torrey Pines. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Based on your corrective action and planned followup, you are not required to formally respond to this item of noncompliance.
