This refers to the routine inspection conducted by Mr. T. Kenny of this office on December 1-31, 1984 at Indian Point Nuclear Generating Station, Unit 2, Buchanan, New York of activities authorized by NRC License No. DPR-26, and to the discussions of our findings held by Mr. T. Kenny with Mr. M. Selman and members of his staff at the conclusion of the inspection.

Areas examined during this inspection are described in the report enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, certain areas of concern have been identified. They are delineated in this report and were addressed to your management representatives at the exit meeting conducted by Mr. Kenny. With regard to these concerns we request a response to us in writing which 1) reaffirms and upgrades commitments made in your letter dated November 16, 1983 (O'Toole to Martin) dealing with design modifications and drawing control; 2) delineates the concerns your management representatives expressed at the exit meeting with regard to the Safety Injection-Boric Acid event of December 28, 1984; and, 3) forwards a safety analysis for the auxiliary feed pump steam isolation valves addressing the inspector's concern delineated in Section 7 of this report.

Your responses directed by this letter are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.


