Dear Ms. Puntenney:

This is the final response to your letter dated June 30, 1984, in which you requested, pursuant to the Freedom of Information Act (FOIA), copies of documents pertaining to (1) the Full Scale Joint Emergency Exercise held at the Enrico Fermi 2 Atomic Power Plant on June 26 and 27, 1984, and (2) whether the Fermi 2 nuclear plant meets the standards outlined in 10 CFR 50.47 (Emergency Plans).

In my previous letter to you dated December 27, 1984, I informed you that additional documents were being reviewed. The review has now been completed.

Documents 1 and 4 through 7, listed on the enclosed Appendix, are being released in their entirety and are enclosed.

Portions of the enclosed documents which are listed at numbers 2 and 3 on the Appendix are being withheld by the Federal Emergency Management Agency (FEMA). These evaluations pertain to a critique of emergency plans by an individual member of the Regional Assistance Committee (RAC). An individual RAC member's critiques qualify for withholding pursuant to Exemption 5 of the FOIA (5 U.S.C. 522(b)(5)) to protect and encourage the free, frank and candid opinions and recommendations of individuals in evaluating the effectiveness of off-site planning.

The person responsible for this denial is Mr. Samuel W. Speck, Associate Director, State and Local Programs and Support, FEMA.

This denial may be appealed in writing to the Director, Office of Public Affairs, FEMA, 500 C Street, SW, Washington, DC 20472, within 30 days of the receipt of this letter.

This completes the Nuclear Regulatory Commission's action on your request.

This request should include any or all materials used to determine or evaluate onsite and offsite emergency response plans for Detroit Edison's Fermi 2 nuclear plant.

- 2.) Any or all documents and materials pertaining to whether the Fermi 2 nuclear plant meets the standards outlined in 10 CFR 50.47 (Emergency Plans). This should also include any materials and documents that pertain to 50.47 (b) 1-16 in which the offsite emergency response plans for nuclear power reactors must meet sixteen required standards.

This request should include any or all transcripts, tapes, memos videos, logs, evaluation reports, senario descriptions, debriefing notes and documents including tapes, minutes of all meetings held, and evaluator and observer memos, notes, and reports.

Pursuant, 5 USC 552 (a)(4)(A), we hereby request waiver of all fees in connection with this request "because furnishing the information can be considered primarily benefitting the general public." If any fees are to be charged in connection with this request, please notify us in advance for approval at the above listed number or at 313-241-7340. This advance notice shall not be necessary if the fees are to be less than \$20.00 in total.
