This is in partial response to Mr. John Clewett's letter dated August 7, 1984, in which he requested, pursuant to the Freedom of Information Act, copies of all agency records relevent to and/or generated in connection with either of the following:

- 1. An incident at the Callaway nuclear plant, occurring on or about July 4, 1984, in which eight circuit breakers were switched off, cutting power to certain plant equipment; and
