By letter dated March 28, 1996, and supplemented by a letter dated April 23, 1996, South Carolina Electric and Gas Company (SCE&G) requested approval for the use of the alternative rules of ASME Boiler and Pressure Vessel Code, Section XI Code Case N-522 for the Virgil C. Summer Nuclear Station.

The staff has reviewed SCE&G's request for approval to use the alternative rules of ASME Section XI Code Case N-522, dated December 9, 1993, "Pressure Testing of Containment Penetration Piping, Section XI, Division 1" for the system pressure testing on certain Class 2 piping systems that penetrate containment. Based on the information submitted, SCE&G's proposed alternative is authorized pursuant to 10 CFR 50.55a(a)(3)(i) as the implementation of the Code Case N-522 provides an acceptable level of quality and safety. SCE&G's proposed use of Code Case N-522, is authorized for the duration of the currently approved ISI program plan interval. The staff's related safety evaluation and conclusions are contained in the Enclosure.
