In a letter submitted to the Document Control Desk (reference a.), South Carolina Electric & Gas Company (SCE&G) provided, as an attachment, a proprietary Westinghouse report entitled "VCSNS RSG/Uprating: Best Estimate Large Break LOCA Final Analysis Report". In a subsequent letter to the Document Control Desk (reference b.), SCE&G superseded reference a. due to a change in the analysis methodology used for Large Break LOCA; however, SCE&G did not request the return of the proprietary report. Since there is no longer a need for the NRC to review the Best Estimate methodology submitted by reference a. and to avoid potential confusion over the method used for our uprate efforts, SCE&G requests that the proprietary attachment in reference a. be returned to SCE&G.

Should we desire to utilize Best Estimate methodology in the future, a Technical Specification amendment request will be submitted which will include the updated VCSNS Best Estimate Large Break LOCA Final Safety Analysis report.




