The NRC Regional Staff has been pursuing the "welder B" issue and expects to issue an inspection report within the next few weeks. In the course of our inspections the Staff has identified issues potentially related to plant safety. As is normal when such issues are found during an inspection, we will meet with the licensee in an enforcement conference to inform them of the safety issues identified so corrective action may be commenced. This enforcement conference is scheduled for March 13, 1984 in Region 11, Atlanta, Georgia.

A meeting summary will be included in the inspection report when issued. As requested by the Board, the Board and all parties will receive a copy of the inspection report.
