Gentlemen:

The Division of Licensing (DL) staff approved your application dated July 14, 1983, with the issuance of Amendment Nos. 75, 82, 83 and 85 to Facility Operating License No. DPR-66 on December 13, 1983, November 8, 1984, November 13, 1984 and December 19, 1984, respectively, and with the issuance of an exemption on November 19, 1984. This application proposed certain Technical Specification changes relating to (1) AC power distribution system and administration changes, (2) containment air locks, and (3) blocking or bypassing safety action of channels of the protective system for the Beaver Valley Power Station Unit No. 1. A Class II fee (\$1,200) was remitted with your application pursuant to 10 CFR 170.22 of the March 23, 1978 regulations.

Based on information provided by the DL staff as the result of their final review of your application, it has been determined that the Class II fee (\$1,200) remitted is appropriate for Item (1) above since the changes were administrative in nature and that a Class III fee (\$4,000) each is appropriate for Items (2) and (3) since the reviews involved consideration of a single and separate safety issue for each. Therefore, you are requested to remit the additional sum of \$8,000 to this office to complete the fees required for your July 14, 1983 application.

It is NRC policy not to assess fees for applications which were filed prior to June 20, 1984, if the application is approved pursuant to 10 CFR 50.12. If, however, a license amendment is issued or the request is otherwise approved (e.g., pursuant to 10 CFR 50.48, 50.55a(g), etc.), or is denied by NRC, fees are applicable. On this basis, it has been determined that an exemption, pursuant to 10 CFR 170.11(b), from the fee requirements of the March 23, 1978 regulations is authorized by law and such exemption is otherwise in the public interest and is hereby granted for those portions of the July 14 application which were approved pursuant to 10 CFR 50.12 on November 19, 1984.
