Applicants have received a letter from NRC Staff Counsel (dated November 7, 1984) requesting that the deadline established at the October 16, 1984 prehearing conference for submission of the Staff's Phase II report on construction quality assurance be extended from November 16 until December 21, 1984. As indicated in Staff Counsel's letter, Applicants do not oppose that request.

Accordingly, Applicants request that the Board issue an order establishing January 21, 1985 (30 days after the Staff's Phase II report would be due) as the deadline for responses to the Staff's report by the Applicants, CCANP and the State of Texas. As indicated by the Board at the prehearing conference (Tr. at 10741-742), such responses should also include a specification of those issues arising from the Staff's report, if any, for which the parties believe a hearing is required.
