Dear Mr. Millar:

This is in partial response to your letter dated March 26, 1984, in which you requested, pursuant to the Freedom of Information Act (FOIA), documents concerning the Office of Inspector and Auditor's two reports regarding the Comanche Peak facility.

The documents listed on Appendix A are enclosed.

Portions of documents 1, 3 and 4 listed on Appendix B are being withheld from public disclosure pursuant to Exemption (5) of the FOIA (5 U.S.C. 552(b)(5)) and 10 CFR 9.5(a)(5) of the Commission's regulations. The deleted information consists of the advice, recommendations and opinions of the Office of Inspector and Auditor to the Commission. The nonexempt portions of these documents are enclosed.

Portions of document 2 listed on Appendix B are being withheld from public disclosure pursuant to Exemption (7)(C) of the FOIA (5 U.S.C. 552(b)(7)(C)) and 10 CFR 9.5(a)(7)(iii) of the Commission's regulations because release of the information would constitute an unwarranted invasion of personal privacy. The nonexempt portions of this document are enclosed.

Pursuant to 10 CFR 9.15 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure and that its production or disclosure is contrary to the public interest. The person responsible for this denial is Sharon R. Connelly, Director, Office of Inspector and Auditor.

This denial may be appealed to the Commission within 30 days from the receipt of this letter. Any such appeal must be in writing, addressed to the Secretary of the Commission, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision."

The review of additional documents is ongoing. As soon as our review is completed, we will be in touch with you.

The cost of reproducing documents is seven cents (\$0.07) per page. The charge for reproducing the enclosed documents is \$30.45. When we have completed the processing of your request, you will be billed by our Division of Accounting and Finance for the enclosed documents as well as any additional documents which are provided to you.
