SUBJECT: REPORT NO. 50-395/84-22

The NRC Systematic Assessment of Licensee Performance (SALP) Board has completed its periodic evaluation of the performance of the V. C. Summer facility. The V. C. Summer facility was evaluated for the period March 1, 1983, through June 30, 1984. The results of the evaluation are documented in the enclosed SALP Board Assessment. In the past, as part of the SALP program, we have routinely met with South Carolina Electric & Gas Company officials to discuss the results of the SALP Board's evaluation. The format of the SALP program has recently been revised so that this meeting is no longer a requirement, but may be held as a public meeting at the discretion of the licensee or NRC. In consideration of this revised format, please contact this office within ten days of the date of this letter to discuss the need for a meeting.

The performance of the V. C. Summer facility was evaluated in the operational functional areas of plant operations, radiological controls, maintenance, surveillance, fire protection, emergency preparedness, security and safeguards, licensing activities, and the quality assurance program.

The SALP Board evaluation process consists of categorizing performance and the performance trend in each functional area. The categories which we have used to evaluate the performance and the performance trend of your facility are defined in Section II of the enclosed SALP Board Assessment. Any comments which you have concerning our evaluation of the performance of your facility should be submitted to this office within 20 days following the date of this letter or the date of the meeting on this SALP assessment (if held).

Your comments, if any, will appear as an enclosure to the Regional Administrator's letter which issues the SALP Board Assessment as an NRC Report. In addition to the issuance of the assessment, this letter will, if appropriate, state the NRC's position on matters relating to the status of your safety programs.

In accordance with Section 2.790 of NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the SALP Report will be placed in the NRC's Public Document Room.
