#### WOLF CREEK TASK FORCE WEEKLY REPORT NUMBER 1

(Report Period 7/25-31/84)

NOTE: The purpose of this report is to communicate activities, plans, progress, problems, etc., to NRC management and Task Force participants. The weekly report will not provide draft information, incomplete inspection results, potential violations, etc.; it will summarize/digest such completed and issued actions.

#### Fire Protection Team

Entrance meeting for fire protection program review was held July 30, 1984. This inspection is to review the applicant's compliance to the fire protection program as provided in BTP APCSB 9.5-1 and Appendix R of 10 CFR Part 50.

The inspection team is composed of M. Murphy (RIV), R. Mullikin (RIV), C. Ramsey (RIII), R. Ferguson (NRR), H. Thomas (BNL), and A. Cuppola (BNL). The onsite inspection is scheduled for completion August 3, 1984. The report will be issued as promptly as possible, but there may be difficulties with BNL input completion due to jury duty for H. Thomas on August 6-10, 1984, and assignment of Thomas and Cuppola to the Byron plant inspection, August 13, 1984; we are expediting input to avoid report delays.

The team provided a copy of the latest NRC Callaway fire inspection report (dated June 22, 1984) to KG&E for comparison to Wolf Creek conditions. At present, the Wolf Creek safe shutdown procedure is not written using the "Total Loss of Control Room" premise.

# Construction Inspection

On July 30, 1984, a five-man team of Region IV inspectors arrived onsite for a week long inspection in the following areas:

In addition, two EG&G-Idaho personnel, D. Baxter and H. Stromberg, arrived onsite on July 30, 1984, for a two-week effort to examine KG&E actions in  $10 \ \text{CFR} \ 50.55(e)$  items and IE Bulletins.

Collins, and others, agreement in principle was reached regarding Region III assistance to Region IV in the Wolf Creek inspection. Telephone discussions among R. L. Spessard and R. Walker (RIII), L. E. Martin and R. P. Denise (RIV), on July 30, 1984, further refined the assistance activities, with some changes made to add additional modules and delete NUREG-0737 items and emergency procedures review. A visit to the site by Spessard, Walker, Martin, and Denise is scheduled for August 8, 1984.

# Other Activities

L. Martin arrived at the site on July 30, 1984 for a week long visit. R. Denise visited the site July 30 through August 1, 1984.

# General Assessment

Inspection activities are proceeding as planned and scheduled. KG&E forecasts a fuel load date of November 1, 1984 (as of July 18, 1984). Some slippage in Hot Functional Tests and SIT/ILRT is evident. There is no basis to adjust the NRC plan at this time.
