Gentlemen:

This is to confirm our understanding of your intended actions regarding additional review of information obtained during background investigation (BI) of security force personnel at the Limerick Nuclear Generating Station. The additional review has been deemed necessary by the disclosure on November 8, 1984 that a member of the security force had falsified his employment history records. This matter was discussed during telephone conversations between Messrs. R. Deneen, R. Weindorfer and J. Basilio of your staff and Mr. R. Keimig of this office on November 9, 1984.

We understand that you intend to take the following actions:

1. Conduct a review of information obtained during BIs on all presently employed security force personnel, within five working days.
2. Initiate prompt action to resolve any discrepancy between information provided by a member of the security force and information obtained during the BI.
3. Initiate prompt action to verify any instance where the previous employment of a security force member was not definitely confirmed during the BI.
4. Establish and implement measures to improve the effectiveness of BIs for security force personnel.
5. Inform this office of the results of your actions, in writing, with 10 days of completion.

If our understanding of your intended actions is not correct, inform this office by telephone within 24 hours, and in writing within five days.
