This acknowledges the receipt of your letter of October 25, 1984, which transmitted Revision 20 to the McGuire Physical Security Plan.

Our review of the changes has found most of the portions to be consistent with the provisions of 10 CFR 50.54(p). Accordingly, they are acceptable for inclusion into the Plan. However, as indicated in the enclosure, certain other changes are in need of minor administrative clarifications. On November 9, J. W. Davis of your Nuclear Engineering Services Staff and W. Tobin of Region II agreed that these clarifications would be submitted by November 23, 1984.

The enclosure to your letter is being withheld from public disclosure because it contains Safeguards Information and must be protected in accordance with the provisions of 10 CFR Part 73.21.
