This transmits the findings of the routine safety inspection by Messrs. A. R. Blough and J. H. Williams on September 1 - October 10, 1984 at the Peach Bottom Atomic Power Station, Deita, Pennsylvania. These findings were based on observation of activities, interviews, measurements and document reviews, and have been discussed with Mr. R. S. Fleischmann of your staff.

An apparent violation of NRC requirements is cited in Appendix A and categorized in accordance with 10 CFR 2 Appendix C and Federal Register Notice 49 FR 8583 (March 8, 1984). Because the violation was corrected, including measures to prevent recurrence, during the inspection, a written response is not required.


