Subject: Modification No. 5 to Task Order No. 19 entitled. "Individual Plant Examination (IPE) Reviews - Internal Events - Human Factors Only (Cooper) under Contract No. NRC-04-91-069

The purpose of this modification is to increase the contract ceiling amount by \$898.04 to cover the overrun costs on Task Order No. 19. Accordingly, the task order is hereby modified to read as follows:

The first sentence of Paragraph 3 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 19 shall be in effect from September 30, 1993 through March 31, 1996, with a total cost ceiling of \$23,155.63. The obligated amount of this modification is \$898.04. The amount of \$21,699.77 represents the total estimated reimbursable costs and the amount of \$1,455.86 represents the fixed fee for a revised ceiling of \$23,155.63."
