Subject: Modification No. 6 to Task Order No. 14 entitled, "Individual Plant Examination (IPE) Reviews - Internal Events - Human Factors Only (Duane Arnold) under Contract No. NRC-04-91-069

The purpose of this modification is to increase the contract ceiling amount by \$730.97 to cover the overrun costs on Task Order No. 14. Accordingly, the task order is hereby modified to read as follows:

The first sentence of Paragraph 3 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 14 shall be in effect from April 14, 1993 through December 31, 1995, with a total cost ceiling of \$20,769.56. The obligated amount of this modification is \$730.97. The amount of \$19,458.70 represents the total estimated reimbursable costs and the amount of \$1,310.86 represents the fixed fee for a revised ceiling of \$20,769.56."




