Subject: Modification No. 4 to Task Order No. 26 entitled. "Individual Plant Examination (IPE) Reviews - Internal Events - Human Factors Only (San Onofre Units 2 & 3) under Contract No. NRC-04-91-069

The purpose of this modification is to increase the contract ceiling amount by \$755.38 to cover the overrun costs on Tack Order No. 26. Accordingly. the task order is hereby modified to read as follows:

The first sentence of Paragraph 3 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 26 shall be in effect from March 3, 1994 through March 31, 1996, with a total cost ceiling of \$20,947.08. The obligated amount of this modification is \$755.38. The amount of \$19.626.16 represents the total estimated reimbursable costs and the amount of \$1,320.92 represents the fixed fee for a revised ceiling of \$20,947.08.
