Subject: Modification No. 7 to Task Order No. 15 entitled, "Individual Plant Examination (IPE) Reviews - Internal Events - Human Factors Only (Palisades) under Contract No. NRC-04-91-069

The purpose of this modification is to increase the contract ceiling amount by \$955.76 to cover the overrun costs on Task Order No. 15. Accordingly, the task order is hereby modified to read as follows:

The first sentence of Paragraph 3 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 15 shall be in effect from April 14, 1993 through March 31, 1996, with a total cost ceiling of \$20,369.46. The obligated amount of this modification is \$955.76. The amount of \$19,099.54 represents the total estimated reimbursable costs and the amount of \$1,269.92 represents the fixed fee for a revised ceiling of \$20,369.46."


