Subject: Modification No. 5 to Task Order No. 20 entitled, "Individual Plant Examination (IPE) Reviews - Internal Events - Human Factors Only (Dresden 2 & 3) under Contract No. NRC-04-91-069

The purpose of this modification is to increase the contract ceiling amount by \$399.79 to cover the overrun costs on Task Order No. 20. Accordingly, the task order is hereby modified to read as follows:

The first sentence of Paragraph 3 of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order No. 20 shall be in effect from September 30, 1993 through March 31, 1996, with a total cost ceiling of \$19,748.73. The obligated amount of this modification is \$399.79. The amount of \$18,483.15 represents the total estimated reimbursable costs and the amount of \$1,265.58 represents the fixed fee for a revised ceiling of \$19,748.73.
