SUBJECT: MEETING TO REVIEW THE FINAL DESIGN AND SEISMIC ANALYSIS FOR NUCLEAR ISLAND STRUCTURES AND FOUNDATION MAT

Dear Mr. Liparulo:

As part of the design review, the Nuclear Regulatory Commission (NRC) Civil Engineering and Geosciences Branch (ECGB) and its contractors need to meet with Westinghouse to discuss and review the following items:

1. Final design for the nuclear island foundation mat
2. Final seismic analysis and design of nuclear island structures
3. Design of exterior walls of nuclear island structures due to the embedment pressure of soil

The meeting will also include the following items:

1. Discussion of NRC foundation mat confirmatory analysis results
2. Resolution of major issues documented in the February 20, 1996, NRC letter
3. Discussion of revised Standard Safety Analysis Report Sections 3.7 and 3.8
4. Resolution and status summary of DSER open items

This meeting is tentatively scheduled with your staff for June 17 through 21, 1996, in San Francisco, California. To maximize the review efficiency, we request that Westinghouse respond to the staff when it is assured that the final design and analysis of the above mentioned items are ready for NRC review.
