SUBJECT: NRC INSPECTION REPORT NO. 50-443/96-02 AND NOTICE OF VIOLATION

Dear Mr. Feigenbaum:

From February 13, 1996 through April 1, 1996, Mr. D. Mannai of this office conducted a resident inspector safety inspection at the Seabrook Station, Seabrook, New Hampshire. Areas relevant to the health and safety of the public examined during this inspection are described in the enclosed report. Our findings were based upon observations of performance and independent evaluations of safety systems and quality records. The preliminary results were discussed with Mr. J. Grillo and other members of your staff at the conclusion of the inspection.

Overall, your staff operated Seabrook Station safely and effectively. Senior station management and the staff demonstrated strong safety perspectives during routine and emergent operational activities. In contrast, based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements. Specifically, foreign material exclusion controls were not implemented during surveillance activities on the risk significant safety-related emergency feedwater system. Although no adverse safety consequences resulted, the violation was of concern since the potential to affect proper operation of all three safety-related steam supply valves to the turbine driven emergency feedwater pump existed. Secondly, the security department failed to implement its procedure to address the continual behavioral observation program requirements. Although no known personnel were improperly granted assess to Seabrook, the security program was violated. Separately, our inspectors identified other conditions with the potential to impact safe operation that station personnel did not identify or critically question and correct. Netwithstanding the minimal actual safety significance associated with the conditions, station personnel did not demonstrate effective problem identification and resolution.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. Your response may reference or include previous docketed correspondence, if the correspondence adequately addresses the required response. After reviewing your response to the Notice, including your proposed corrective actions and the results of future

inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.
