Subject: NRC Safety/Security Assessment - Diablo Canyon Unit 1

This letter refers to the special assessment of the safety/security interface at Diablo Canyon Nuclear Generating Station (NRC License No. DPR-76) conducted by L. R. Norderhaug of this office and K. Byers, P. Brown and R. Hadley, NRC consultants, October 29, 31 and November 5-9, 1984. It also refers to the discussion of the findings held by the assessment team with Mr. Thornberry and members of his staff on November 9, 1984 and telephone conversations with R. Todaro on November 19, 21 and 29, 1984.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the assessment consisted of selective examinations of procedures and records, interviews with facility and contract personnel, and observations by the team.

Within the scope of this assessment, no violations were observed. However, we note your position with regard to NRC Information Notice 83-36 (See paragraph 6.1 of enclosed report). Please provide, us within 30 days of the date of this letter, a description of your assessment of the applicability of IN 83-36 to your facility, as it applies to the anti-passback feature.

In accordance with Section 2.790(d) of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, documentation of findings related to your security program and procedures for protecting your facility are exempt from public disclosure; therefore, the enclosed inspection report will not be placed in the Public Document Room.
