This is in further response to your letter dated April 27, 1984, in which you requested, pursuant to the Freedom of Information Act (FOIA), five categories of records regarding an FOIA request by Robert Belair, on behalf of Suffolk County, and the Shoreham Nuclear Power Station.

With regard to categories one, two, and three of your request, by letter dated May 14 we informed you that the subject FOIA request (FOIA-84-250), two responses dated May 4 and May 8, and certain subject records are available for public inspection and copying at the NRC Public Document Room (PDR). Since that date, we have placed additional subject records in the PDR by letters dated May 18, May 21, and May 23.
