Dear Mr. Glasspiegel:

This is a partial response to your letter dated May 18, 1984, in which you requested, pursuant to the Freedom of Information Act, copies of documents regarding (1) all prefiled testimony filed in NRC construction permit or operating licensing hearings; (2) all speeches or published papers on subjects relating to nuclear power; (3) all internal memoranda (excluding final, published NRC inspection and investigation reports) referencing the South Texas Project. You listed nine NRC personnel who are covered by this request.

The documents listed on Appendix A are responsive to Item (1) of your request. These documents are already available in the Nuclear Regulatory Commission's Public Document Room (PDR), 1717 H Street, NW, Washington, DC 20555. You may request copies of these documents by referring to the accession numbers.

The enclosed documents, as listed on Appendix B, are Freedom of Information Act (FOIA) requests. Many memoranda subject to item 3 of your request have been addressed in response to these previous FOIA requests. These responses are maintained in PDR folders under the FOIA numbers and names. You may obtain copies of these documents at the PDR by referring to the FOIA folders as indicated on the Appendix.


There is no charge for inspecting records maintained at the PDR. The charge for copying records maintained at the PDR is five cents (\$0.05) per page, as specified in 10 CFR 9.14(a). If you do not wish to visit the PDR to inspect or copy these records, you may obtain a copy by calling (202-634-3273) or writing directly to the PDR. Upon your agreement to pay the copying charges, the PDR will arrange for the records to be copied by a private contractor servicing the PDR. You will be billed by the private contractor for copying charges, plus tax and postage.
