This is a request for information under the Freedom of Information Act. We request information pertinent to the South Texas Project (STP) facility in Matagorda County, Texas operated by Houston Light & Power (HL&P). The time frame in question is 1988 to the present. The materials we request are the following:

- 1.) All reports issued by and correspondence to, from or concerning the NRC Office of Inspector General relating to STP;
- 2.) All reports pertinent to HL&P employee concerns or complaints to the NRC or to HL&P, including those documents pertinent to the HL&P programs for handling employee complaints or concerns;
- 3.) All correspondence, including NRC commissioner correspondence, pertinent to HL&P employee complaints or concerns;
- 4.) All attachments to the above materials.

Please note that all materials have been requested, including but not limited to any type of memorialization, correspondence, depositions, opinions or reports or other legal documents issued by, or pertinent to adjudications by, the NRC, HL&P or the US Department of Labor as they may pertain to employees at STP.

Please also note that employee includes past or present, full or part time, employees and all past or present contract employees, whether or not they were employees or contract employees at the time of filing any complaint or concerns with the NRC or with HL&P.

Please also note that the categories requested cover all Docket 50 Categories and all Non-Docket categories as well as the OIG reports.


